



St. John's 2019-2024 Parks and Recreation Master Plan includes new bike and trail plans!

ST. JOHN HAS A NEW MASTER PLAN FOR BIKE TRAILS!

The plan recognizes that, despite recent efforts to build and extend our well-used trails and bike paths, there is little connectivity among the different trails, and some neighborhoods totally lack direct access. But available open space provides opportunities to plan for new trails and pedestrian facilities fully integrated with developing subdivisions and neighborhoods.

WE ARE FOCUSED ON A BIKE TRAIL SYSTEM IN EVERY NEW SUBDIVISION!

Our adopted Trail and Bike Plan identifies locations where new trails and pedestrian corridors can be developed and established. When fully developed, the plan will close pedestrian gaps between the various parts of Town, provide additional connectivity to all parts of the Town and beyond, and create new recreation and transportation options.

Investing in Our Children & Families



Financial stability and conservancy are part of St. John's core values and a priority for the Town Council. Here's a look at the numbers:

AA RATING

In February 2014, Standard & Poor's Ratings Services upgraded the Town's credit rating from AA- to AA. The Town remains at AA today, a very good and stable financial position.

STRONG ECONOMY

St. John's economy is very strong, with a projected per capita effective buying income of 112% of the national level and per capita market value of \$124,157. The county unemployment rate was 5.1 percent in 2017 and our local area is expanding with more retail shops and restaurants. Residential permits are up since 2014 and the Town has room to expand.

STRONG BUDGETING

St. John's budgetary performance had operating surpluses of 3.6% across all governmental funds in fiscal 2018. For fiscal 2019, officials anticipate using reserves for roadway infrastructure and expect the results to come in better than projected. We expect the town's budgetary performance to remain strong for fiscal 2019 (Dec. 31) and 2020.

GENERAL FUND

The General Fund operating receipts exceeded projections and were over budget by \$748,136 or 46.98%, and operating disbursements (expenses) were under budget by \$243,205 or 3.61% in 2018.

NEW HOMES

Construction of new homes exceeded expectations and remained strong in 2018 with 323 new residential housing starts that generated fees of \$974,526, 66.02% over the budgeted amount.

PROPERTY TAXES

The property taxes levied were \$6,296,376 and collections were \$6,113,294 for a shortfall of just \$183,082 or 2.91%.

LOW CORPORATE TAX

The second-lowest corporate tax rate in Lake County is in St. John at \$0.4965 per \$100 of Assessed Value for 2019, and St. John's AV has far out-paced that of the County! St. John has a long history of AV increasing and the corporate tax rate decreasing, indicating strong financial management.

HIGHEST MEDIAN INCOME

St. John ranks as the 11th largest populated municipality in Lake County, but holds the highest median income and median home value in 2015, at \$96,631 and \$260,961, respectively. St. John also has the highest percentage of owner-occupied housing units at 98% of all households.




OUR FIRE DEPARTMENT

The St. John Fire Department is made up of approximately 40 volunteer/paid-on-call, and 12 full-time members. Our full-time staff includes all State Certified firefighters and licensed pre-hospital medics and 20 of our paid-on-call members are also Emergency Medical Technicians. They are the support group that continues to be the foundation of our success, responding to both medical and fire-related emergencies.
